- Ensures timely payments and receipts of broker invoices regarding insurance and reinsurance contracts.
- Handles the cash entry and application process.
- Follow up with brokers regarding overdue balances to reduce Accounts Receivables.
- Analyze, review and maintain accurate treaty accounts. This includes handling Contingent Commissions, Sliding Scale Commissions, Retrospective Rate Adjustments and Premium Adjustments and processing accounts, ensuring data captured is accurate an within agreed timeframes.
- Manage complex treaties which include preparing accounts and analyzing statistics.

- Assist in managing receivables and suspense amounts.
