The ceded reinsurance director will be working on all aspects of outwards treaty placement activities for mainly casualty, professional lines and other long tailed business within the central global Ceded Re Group to facilitate and support the growing global operations of Sompo International.

Responsibilities include:

Reinsurance Purchasing

- Assist the reinsurance buying process for Sompo Intl's global business units through intermediaries and with reinsurers, both direct and broker market (submission, RFPs, reinsurer audits – claims & underwriting, transactional, presentation to reinsurers, etc...)
- Collect and prepare data in close collaboration with the business units and other disciplines such as actuarial, corporate underwriting, legal, and claims.
- Conduct meetings with brokers, reinsurers and underwriters on various reinsurance and retro placements
- Coordinate Global placements with central Ceded Re Group, Ceded Re Operations and Accounting



- Help build reports to track reinsurance metrics, such as:
 - Historical reinsurance structure, spend, and loss history. Gross & net results.
 - Objective of reinsurance; alternatives.
 - Economic impact XOL: expected loss cost by layer vs. expected reinsurance premium vs. premium actually collected in layer, experience vs. exposure analysis, frequency/severity, non-concurrencies
 - Economic impact QS: pro-forma P&L analytics on gross & net basis, ceding commission & anticipated over-ride
 - Risk transfer analysis

Reinsurance Administration

- Maintain Treaty listing; provide treaty schematics and periodic reports to management & functional areas as necessary.
- Facilitate the booking and implementation of contract terms in corporate systems (such as ProCede and Genius)
- Collaborate with claims, accounting and other disciplines to ensure:
 - the accurate production of bordereaus, reports and calculations
 - cessions are provided to reinsurers in accordance with contract terms and conditions
 - recoverables are collected on a timely basis.
- Facilitate profit sharing calculations and other reinsurance mechanics such as loss ratio caps, sunset clauses...

Other Areas of involvement to include:

- Internal Reinsurances
- Retrocession placements for the reinsurance segment
