The candidate must possess technical knowledge, legal insight, accuracy, responsiveness and display a high degree of customer service. We seek a claims professional with high level casualty or excess insurance claims experience. The successful candidate must be able to manage an excess line portfolio while providing insight and analysis on claim exposures to management and our underwriting partners. The applicant must be an effective verbal and written communicator and work well in a team environment. The candidate must be agile, effective at priority setting, willing to travel to attend mediations (under proper conditions), and one who excels at interaction with internal and external customers, underwriters, peers and management.

- Analyze loss and expense trends on a portfolio of claims and assist in the development and implementation of plans to improve results

- Demonstrated ability to manage multiple projects to successful completion
- Strong ability to prioritize and work independently; self-starter and a team player
- Strong computer skills (MS Word, Excel, Outlook and various in-house claims systems – Guidewire, Genius, ImageRight is a plus)
