As a recognized senior level subject matter expert in supporting multinational insurance products, the role is responsible for the overall performance of the Multinational BU, and it's collaborative integration into the wider Sompo organisation within Northern Europe.

Responsibilities include:

- Direct management responsibilities for Multinational business in assigned territories
- Development, implementation and oversight of operational workflow and processes for inbound and outbound Multinational business in the Northern Europe region
- Take responsibility for ensuring accurate submissions are accepted, polices are issued, reinsurance transactions and bookings are processed, and premiums are remitted in a timely, accurate fashion
- Be the go-to Multinational subject matter expert within the assigned geographies
- Prepare and provide quotations to brokers and clients, with support from local underwriters, in a timely manner
- Builds strong relationships with brokers, clients, underwriters and distribution to promote Sompo Multinational and help identify, support and drive growth strategies, account retentions and new business wins.
- Attend client and broker meetings including site visit with engineers where necessary.
- Supports the PO with compliant pricing and issuance of local policy with delegated underwriting authority up to a certain threshold, with referral to local Product Underwriter/CUO for any risk falling outside LOA.
- Directs, oversees, and participates in developing appropriate responses to underwriting queries around country capabilities, and regulatory requirements for the EMEA region.



- Ensure global Multinational E2E process, procedures and controls are adhered to in close collaboration with the Multinational Global Operations team
- Produce, monitor and act on operational performance reporting/SLAs in conjunction with Regional Service Delivery Lead
- Manage assigned direct reports and develop their knowledge, skills and experience
- Collaborate with internal and external partners to deliver the best service
- Coordinates and participates in underwriting audits across the enterprise, as needed, to ensure compliance with key regulatory requirements
- Handles multiple lines of business (Property, Liability, Financial Lines, Marine Cargo)
