The role will primarily be responsible for the direct tax matters of the Group's entities in Luxembourg, Germany, Italy, Spain and Switzerland and it will report into the Head of Tax – Europe.

This role would suit an experienced insurance tax professional who is seeking exposure to a wide array of multi-national tax areas and opportunities to progress their career in a growing insurance group. The role can be based from either a Luxembourg or London office location and there is also flexibility around remote working.

## Responsibilities include:

- Manage the accurate preparation and timely filing of all European direct tax returns and any relevant payments.
- Responsible for IFRS group and local GAAP tax reporting and overseeing the correct tax accounting is maintained in general ledgers.
- Manage production of transfer pricing local files according to OECD and local requirements.
- Lead on providing European direct tax and transfer pricing advice and planning to the business, and build strategic relationships with internal stakeholders across European locations through regular interactions.
- Lead on country by country reporting requirements across Europe and assist with incoming global minimum tax changes.
- Undertake tax due diligence work as European M&A projects arise.
- Monitor the group's European tax risks and ensure compliance with local laws in each jurisdiction as the group expands in Europe and wider afield.
- Oversight of indirect tax matters that impact the European entities and assisting in these as required.
- Effective and appropriate interaction with tax authorities, external Auditors, external advisers and other stakeholders in relation to Sompo's European tax matters.
- Regularly assess and refresh processes and controls to improve direct tax compliance, and ensure tax rate and legislation changes are reflected, reported and communicated to the business.
