We have an exciting new **Senior IT Auditor** position within the Internal Audit team in our **London** office. The role will be to support the IT Audit Manager by planning and reporting on internal audit activities in order to provide assurance on the adequacy, appropriateness and effectiveness of the Information Technology (IT) internal control environment, risk management framework and compliance with policies, procedures and regulatory requirements. Assist and lead operational and integrated IT audits of business and shared service functions, as necessary.

Responsibilities include:

- Plan and perform IT audit assignments to assess the efficiency and effectiveness of IT processes and related controls
- Prepare detailed working papers in TeamMate+ that evidence the work performed and any issues that arise
- Draft, prepare and submit audit findings and present them to senior management. Follow up on remediations of the audit findings and their closure.
- Act as an IT subject matter expert to ensure alignment with best practices
- Collaborate with internal and external stakeholders by sharing expertise and providing accurate and timely information
- Maintain up-to-date knowledge relating to key risk indicators for IT environment, industry related technology risks, and general insurance industry practice
- Perform project assignments as directed, completing the activities within established timelines



- Feed into the Sompo International IT Audit coverage strategy for systems, IT General Controls, Cybersecurity and Infrastructure across both Commercial and Retail insurance entities globally (excluding Japan)
- Proactively track the remediation of open IT Audit Issues
