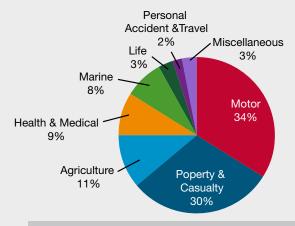


Retail Insurance Business Overview
