The Risk Control Specialist will also be responsible to track trends at an account and book level and communicate effectively with our clients and brokers. - Completing surveys of casualty risks

- Compiles facts from on-site visits and various reports and databases to assess existing processes/practices, determine severity/frequency of problems, and identify needs.
- Assesses and benchmarks customers performance against internal and industry standards.



- Interprets and analyzes data to determine best course of action and/or solution that satisfies customer's risk service needs.
- Conducts cost-benefit analysis to determine how and when a recommended improvement at customer's facility/operation will pay off.
- Participates in training and development of customers.
- Oversees implementation of program(s).
- Provides technical support to assist with implementation of recommendations/actions plans.
- Actively pursues professional development efforts to better meet customer expectations.
- Actively participates in acquiring new business by presenting proposals to potential insureds.
- Assisting the field staff and underwriting in risk evaluation for complex casualty accounts
- Promoting Sompo International's expertise in the marketplace by attending conferences and participating in industry organizations
- Complete Basic Property Surveys as needed
