**DELA VII ZAKONA ZDRUŽENEGA KRALJESTVA O FINANČNIH STORITVAH IN TRGIH IZ LETA 2000 (FINANCIAL SERVICES AND MARKETS ACT 2000)**

**S TEM JE DANO OBVESTILO** v skladu s 114. členom, 2. odst. Zakona Združenega kraljestva o finančnih storitvah in trgih iz leta 2000 (**»zakon«**), da je 10. decembra 2018 Visoko civilno sodišče Njenega veličanstva po 111. členu zakona izdalo sklep, s katerim je odobrilo shemo (**»shema«**), ki predvideva:

(a) da se na SIIE prenese:

(i) neposredno zavarovalno poslovanje družbe SJNKE v EGP in določeno pozavarovalno poslovanje družbe SJNKE v EGP; in

(ii) neposredno zavarovalno poslovanje družbe EWIL v EGP in določeno pozavarovalno poslovanje družbe EWIL v EGP; in

(b) da se na družbo EWIL prenese preostalo poslovanje družbe SJNKE.

Prenos v skladu s shemo stopi v veljavo 1. januarja 2019.

Če v povezavi s katero koli polico v poslih, ki bodo v skladu s shemo preneseni, država EGP, v kateri se tveganje nahaja, pomeni državo EGP, ki ni Združeno kraljestvo (kot so ti izrazi definirani v 2. odstavku 114. člena zakona), in ima imetnik police pravico do odpovedi police kot posledice sheme v skladu z zakonodajo te države EGP, lahko to pravico uresniči v roku 21 dni po javni objavi tega obvestila v tej državi EGP (ali, če je to primerno, v roku, ki je lahko daljši, v kolikor to dopušča zakonodaja te države EGP).

**NOTICE IS HEREBY GIVEN** in accordance with section 114(2) of the Financial Services and Markets Act 2000 (the "**Act**") that on 10 December 2018 an order was made by Her Majesty's High Court of Justice under section 111 of the Act sanctioning a scheme (the "**Scheme**") providing for:

(a) the transfer to SIEE of:

(i) the EEA direct insurance business of SJNKE and certain EEA reinsurance business of SJNKE; and

(ii) the EEA direct insurance business of EWIL and certain EEA reinsurance business of EWIL; and

(b) the transfer to EWIL of the remaining business of SJNKE.

The transfer pursuant to the Scheme is due to become effective on 1 January 2019.

Where, as regards any policy comprised in the business transferred pursuant to the Scheme the EEA State in which the risk is situated is an EEA State other than the United Kingdom (as such expressions are defined for the purposes of section 114(2) of the Act) and the policyholder has a right to cancel the policy as a result of the Scheme under the law of that EEA State, then that right may be exercised during the period of twenty-one days following the date of publication of this notice in that EEA State (or where applicable, during such longer period as may be allowed under the law of that EEA State).
